## **Ohio Manufacturers Applaud House Passage of Historic Tax Reform Bill**

*“Our Elected Leaders Need to Seize This Opportunity, Get Tax Reform Across the Finish Line.”*

[Columbus OH] –The Ohio Manufacturers’ Association (OMA) and the National Association of Manufacturers (NAM) praised the passage of H.R. 1, the Tax Cuts and Jobs Act, by the U.S. House of Representatives today.

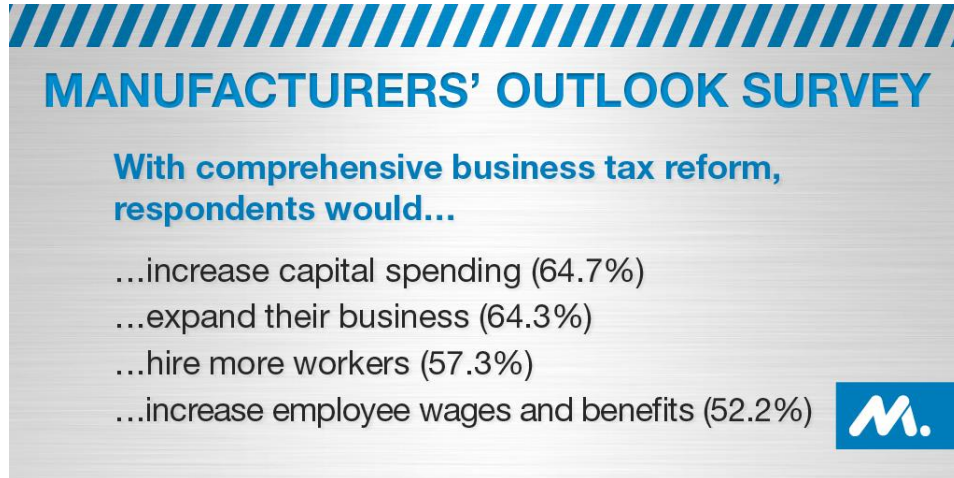
“This is great news for Ohio’s manufacturing workers. The passage of this bill puts us on track for bold tax reform legislation that will empower manufacturers across Ohio and the U.S. Manufacturers large and small know this reform would mean more investment in America and more men and women making things in America,” said Eric Burkland, OMA president. “Ohio manufacturers are grateful to the members of the House who voted for tax reform. And when the Senate takes up its tax reform bill in the coming days, we urge Senators Brown and Portman to stand with manufacturers as well. The current tax system is hurting workers in Ohio. Our elected leaders need to seize this opportunity, get tax reform across the finish line, send it to President Donald Trump’s desk, and grow the American economy.”

“America witnessed history today as the House of Representatives passed the biggest, boldest tax reform in more than 30 years, and every member of Congress who voted for reform showed their constituents they are unequivocally standing up for American manufacturing workers,” added NAM President and CEO Jay Timmons. “This bill moves us closer to achieving the goals manufacturers have sought for decades, and for manufacturers across this country, there is no question that when tax reform becomes law, we’ll be empowered to create more jobs, invest more in America and help lift up working families and improve their lives.”

Passage of H.R. 1 follows months of engagement by manufacturers with Congress and the White House on tax reform. The NAM's most recent quarterly [survey](#) found that if comprehensive tax reform was enacted, two-thirds of manufacturers would increase capital spending and grow their businesses while more than half would hire more workers and increase employee wages and benefits.
